

## ORDINANCE NO 21

### An Ordinance relating to the Sale of Non Intoxicating Malt Liquors

The Village Council of the Village of Finlayson does Ordain:

Section 1: It shall be unlawful to sell non-intoxicating malt liquors within the limits of the Village of Finlayson without first obtaining a license for that purpose from the Village Council of said Village of Finlayson.

Section 2: Non-intoxicating malt liquors shall mean such malt liquors as are defined or described as non intoxicating malt liquors by the laws of the State of Minnesota.

Section 3: There shall be two kinds of licenses, namely;

- a. "On Sale" licenses which shall permit the licensee to sell such non intoxicating malt liquors for consumption on the licensed premises only, and the license fee therefore shall be the sum not to exceed fifty dollars per annum; and such "On Sale" license shall be granted only to such persons and parties and for such places as may be authorized by the laws of the State of Minnesota, within said village.
- b. "Off Sale" licenses shall permit the licensee to sell non-intoxicating malt liquors in original packages for consumption off the premises only and the license fee therefore shall not exceed the sum of ten dollars per annum.

Section 4: All licenses for the sale of non intoxicating malt liquors shall be issued for a period of one year, except that for the purpose of coordinating the time of expiration of licenses in general, such licenses may be issued for a shorter time to expire at a given period of the year in which case a prorate fee shall be charged.

Section 5: Licenses issued hereunder may be revoked by said Village Council with or without cause and in the event of such revocation there shall be refunded to the licensee such part of the license fee paid by him as the unexpired portion of the term of his license bears to the entire term of his license, so revoked.

Section 6: All applications for license to sell non intoxicating malt liquors under this ordinance shall be in writing, signed and verified by the applicant and shall designate the place where sales are to be made. Anyone applying for a license hereunder shall furnish to said Village Council a bond with two or more individual sureties who shall be freeholders of said Village, who shall justify in twice the amount of such bond, or with a corporate surety authorized to do business in the State of Minnesota, to be approved by said council, in the penal sum of \$500.00; which bond shall be conditioned for the faithful compliance of the principal named in said bond with all laws of the State of Minnesota and all ordinances of said Village relating to non intoxicating malt liquors.

Section 7: All licenses issued hereunder shall contain a description of the premises and room where said liquors are licensed to be sold and every license shall be conspicuously posted in the room where sales there under are authorized.

Section 8: Any person violating the provisions of this ordinance shall be guilty of a misdemeanor and upon conviction thereof shall be punished by a fine of not to exceed one hundred dollars (\$100.00) or imprisonment in the county jail of Pine County, Minnesota for not more than ninety (90) days. Adopted this 31<sup>st</sup> day of March, 1933, by the Village Council
